### DISCUSSION

#### 1. Future Funding Options for Emergency Services/Public Safety

Briefing by Chief Doug Hamp (Department of Emergency Services) and Chief Dennis Cassidy (Police Department) and regarding two forms of new tax income as a means to fund the expansion of Emergency Services.

- Seek authorization from the California State Legislature to ask the voters to approve an increase to local (in City) sales tax rate (in place of the ¼ cent reduction just implemented by the State).
- Establish a property-type tax that would involve assessing property owners a tax based upon the degree of emergency service risk inherent to their property and/or the uses thereon.

There is the possibility that both could be sought, working one in conjunction with the other. In either case, the new tax proposals would require a 2/3's majority vote to implement. The earliest a new tax could be put before the voters is November 2001. There will be a total of four meetings scheduled to discuss the matter with the community.
