DISCUSSION~ SENIOR ADVISORY COMMITTEE

Following a lengthy discussion, the City Council and the Senior Advisory Board reached a consensus that rather than expand the existing Senior Center, that a new Center should be constructed when deemed appropriate. In an effort to assist the Senior Advisory Board and the City Council in determining a time to construct a new Center, City Staff was directed to conduct a needs assessment. At a minimum, the assessment should address current/future services for Paso Robles Seniors. The assessment needed to identify who the center was serving, the location of their residence and related socio-economic information. Staff was further directed to prepare a map of City owned properties where a new Center might be constructed in the future.

The Senior Advisory Board and the City Council agreed to meet at least once per year or more frequently if needed.
