A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES CONSENTING TO THE COMMENCEMENT OF ANNEXATION PROCEEDINGS FOR THE ANNEXATION OF CERTAIN INHABITED TERRITORY DESIGNATED AS "ANNEXATION NO. 12"

WHEREAS, it is the desire of the City Council to give its consent to the commencement of such annexation proceedings upon condition that the electors within said territory be informed at the time the petition for annexation is circulated that the question to be submitted to said electors shall be whether the territory shall be annexed, and the property in the territory subjected to taxation after annexation equally with the property within the City of El Paso de Robles to pay the entire bonded indebtedness of the City of El Paso de Robles outstanding or authorized at the date of the first publication of the notice of election, for the acquisition, construction or completion of municipal improvements.
