RESOLUTION NO. 1631 ESTABLISHING SEWER SERVICE CHARGE RATES BY THE CITY OF EL PASO DE ROBLES

BE IT AND IT IS HEREBY RESOLVED BY THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES:

- 1. That the Sewer service charges to be billed on and after September 1, 1971, and continuing until further resolution of the City Council be at the following monthly rates:
 - (a) For each single family dwelling, the sum of Two Dollars and Twenty-five Cents (\$2.25) permmonth,
 - (b) For each single family dwelling unit located upon a building site and under one ownership, whether being served by separate or joint connections, the sum of Two Dollars and Twenty-five Cents (\$2.25) per month.
 - (c) For each single family dwelling unit in any duplex, multiple dwelling or apartment house, the sum of Two Dollars and Twenty-five Cents (\$2.25) per month.
 - (d) For each lot or space in a Mobilhome Park, the sum of Two Dollars and Twenty-five Cents (\$2.25) per month for each such lot or space.
 - (e) For each dwelling unit in any hotel, auto court, or Transient Trailer Space in a Trailer Park or Mobilhome Park, the sum of Ninety Cents (\$.90) per month for each such unit.
 - (f) For each motel unit in any motel, the sum of Ninety Cents (\$90) per month; provided, however, that where the total assessed value of such motel units does not exceed an average of \$750.00 per motel unit, and in that event only the rate shall be Forty-five Cents (\$.45) per month for each such unit.
 - (g) For each boarding house, resthome, hotel, or hospital, the sum of Two Dollars and Twenty-five Cents (\$2.25) per month plus the sum of Forty-five Cents (\$.45) per month for each bedroom available within the building or buildings for such use.
 - (h) For each church, the sum of Two Dollars and Twenty-five Cents (\$2.25) per month plus Two Dollars and Twentyfive Cents (\$2.25) per month for any parsonage or dwelling unit connected thereto.
 - (i) For each establishment or location accepting sewage from vehicles or trailers, the sum of One Dollar and Fifty Cents (\$1.50) per month shall be added to the regular charges.
 - (j) For each office, theater, club house or place of amusement, lodge and business establishment (wholesale or retail) the minimum sum of Two Dollars and Twenty-five Cents (\$2.25) per month for the first 1000 cubic feet of water used. Any excess of 1000 cubic feet of water used shall be added at the rate of Eighteen Cents (\$.18) per 100 cubic feet of water used, and Two Dollars and Twenty-five Cents (\$2.25) per month shall be added for each dwelling unit included in any such establishment.
 - (k) For each public, private or parochial school, an equal monthly charge based upon the following calculations:

- 1. One and Eight Tenths Cents (\$0.018)per month per pupil and employee;
- Plus Nine Tenths Cents (\$01009) per month per pupil for schools with connections to the City Sewer System;
- Plus Two Dollars and Twenty-five Cents (\$2.25) per month for schools with cafeterias;

The charges so calculated shall be based upon school records for the previous school year and the minimum charge for any such school shall be not less that Two Dollars and Twenty-five Cents (\$2.25) per month.

- (1) That Ten Dollars and Eighty Cents (\$10.80) per month be added to each account being served by the City Sewer System and located outside the City Limits and being billed at the above rates. Provided, however, that all charges collected under this section be deposited in a sinking fund account under the "Sewer Maintenance Fund" and shall be used only for the acquisition, construction and reconstruction of sewer truck lines and mains; provided, however, that the city council may authorize by resolution that any such funds be applied to other uses toward the construction, maintenance and operation of the sanitary sewer system.
- (m) That all billing as provided herein be computed and billed on a bi-monthly basis for both the consumption and monthly flat rate charges.
- (n) That the rates established herein be applicable to all metered and flat rate accounts unless a written agreement is entered into between the party affected and the City of El Paso de Robles covering special rate or conditions of service, and where such special rates are justified by extra-ordinary usage conditions, including large industrial water consumers.
