A RESOLUTION DETERMINING TO UNDERTAKE PROCEEDINGS
PURSUANT TO SPECIAL ASSESSMENT AND ASSESSMENT BOND
ACTS FOR THE ACQUISITION AND CONSTRUCTION OF IMPROVEMENTS WITHOUT PROCEEDINGS UNDER DIVISION 4
OF THE STREETS AND HIGHWAYS CODE

EL PASO DEL ROBLES IMPROVEMENT DISTRICT NO. 73-4

RESOLVED, by the City Council of the City of Paso Robles, County of San Luis Obispo, California, that

WHEREAS, based on Certificates duly filed with this Council, all of the owners of more than 60% in area of property subject to assessment, have signed and filed with the Clerk of this City a written petition for undertaking proceedings pursuant to special assessment and assessment bond acts, and to assess the costs thereof upon the properties benefited by said acquisitions and improvements, and waiving proceedings and limitations under Division 4 of the Streets and Highways Code, for the acquisitions and improvements more particularly described in Exhibit "A", attached hereto and incorporated herein by reference;

WHEREAS, the costs and expenses of said contemplated acquisitions and improvements are to be chargeable upon an assessment district, the exterior boundaries of which are the coterminous exterior boundaries of the composite and consolidated area as more particularly shown on a map thereof filed in the office of the City Clerk, which indicates by a boundary line the extent of the territory included in the proposed District and shall govern for all details as to the extent of the Assessment District; and

WHEREAS, the public interest and convenience will be served by the taking of said proceedings;

NOW, THEREFORE, IT IS HEREBY FOUND, DETERMINED AND ORDERED that all of the owners of more than 60% in area of property subject to assessment for said proposed acquisitions and improvements have filed with the City Clerk of this City a written petition for the acquisition and construction of improvements pursuant to appropriate special assessment and assessment bond acts, without further compliance with the provisions or limitations of Division 4 of the Streets and Highways Code.

IT IS FURTHER FOUND, DETERMINED AND ORDERED that said proceedings for the acquisitions and construction of said improvements shall be had pursuant to the Municipal Improvement Act of 1913 and the bonds upon the unpaid assessments thereof shall be issued pursuant to the Improvement Bond Act of 1915.

IT IS FURTHER FOUND, DETERMINED AND ORDERED that the provisions and limitations of Division 4 of the Streets and Highways Code be, and they are hereby, dispensed with.
