RESOLUTION NO. 1937

A RESOLUTION OF THE CITY COUNCIL
OF THE CITY OF EL PASO DE ROBLES, CALIFORNIA,
ESTABLISHING A PORTION OF 12th STREET
UPON WHICH ANGLE PARKING SHALL BE PERMITTED
IN THE CITY OF EL PASO DE ROBLES

WHEREAS, a survey by the City Traffic Engineer was submitted to the Traffic Safety Committee; and

WHEREAS, the Traffic Safety Committee has recommended to the City Council the need for Angle Parking on the north side of 12th Street in front of the Paso Robles Nursing Home, with two (2) parallel parking spaces on each end of the block, and also parallel parking on the south side of the street, between Olive and Chestnut Streets.

NOW, THEREFORE, BE IT RESOLVED that the Director of Municipal Services is hereby authorized and directed to place and maintain, or cause to place and maintain, lines painted on the street pavement for the purpose of parking vehicles in a manner and at the locations as follows:

- 1. Along the north side of 12th Street, starting thirty-five (35) feet east of the centerline of the Chestnut Street right-of-way, paint two (2) parallel parking spaces for the distance of forty (40) feet; then, continuing east, paint diagonal parking spaces within the next two hundred and thirty (230) feet; then paint two (2) parallel parking spaces within a distance of forty (40) feet. The end of the last parking space should be thirty-five (35) feet west of the centerline of the Olive Street right-of-way.
- 2. Along the south side of 12th Street, starting thirty-five (35) feet east of the centerline of the Chestnut Street right-of-way, paint parallel parking spaces for a distance of three hundred and ten (310) feet to a point thirty-five (35) feet west of the centerline of the Olive Street right-of-way.
