PETITION

FOR THE ACQUISITION AND CONSTRUCTION OF IMPROVEMENTS BY SPECIAL ASSESSMENT AND ASSESSMENT BOND ACTS, AND WAIVER OF PRO-CEEDINGS UNDER DIVISION 4 OF THE STREETS AND HIGHWAYS CODE

PASO ROBLES INDUSTRIAL PARK

To the Honorable City Council City of Paso Robles Paso Robles, California

Members of the Council:

The undersigned respectfully petition your Honorable Body and show as follows:

1. That they are all of the owners as shown on the Assessor's Roll or on the County Assessor's records of the County of San Luis Obispo on which general taxes were collected, or more than 60% in area of all of the parcels of property hereinafter described as shown on the last equalized assessment roll used by the County.

2. That you take proceedings and issue bonds pursuant to appropriate special assessment and assessment bond acts for the following acquisitions and improvements:

> (a) The improvement of the City of Paso Robles airport property by clearing, grubbing, excavation, grading, placement of aggregate base and asphalt surfacing together with the installation of water mains, valves, tee's, hydrants, thrust blocks, service connections, pumping facilities and control equipment and the installation of sewer mains, manholes, laterals, lift station, sewage treatment and disposal facilities together with such surface and sub-surface storm drainage facilities as may be necessary.

(b) The acquisition of necessary rights of way and easements and the construction of all work auxiliary to any of the above and necessary to complete the same.

3. That you assess the cost of said acquisitions and improvements together with incidental expense of said proceedings, upon the district benefited thereby, the exterior boundaries of the composite and consolidated area of all parcels of property more particularly shown on a map attached hereto and to be filed in the office of the City Clerk, which indicates by a boundary line the extent of the territory included in the proposed district and which shall govern for all details as to the extent of the assessment district.

4. That you appoint and employ engineers and attorneys to do and perform all of the engineering and legal work and services necessary in the assessment proceedings; and that they be paid a reasonable fee for said services, to be assessed as an incidental expense of said proceedings.

5. That we authorize you to exercise your proper discretion as vested in your pursuant to said Acts to consider all lawful petitions or protests which may be filed therein, and in the exercise thereof to increase, decrease or otherwise modify the work to be done and the boundaries of the assessment district.

6. THE UNDERSIGNED expressly waive the proceedings required, and all limitations, under the "Special Assessment Investigation, Limitation and Majority Protest Act of 1931," being Division 4 of the Streets and Highways Code.
