CITY OF EL PASO DE ROBLES
FOR THE FISCAL YEAR 1983/1984

A RESOLUTION APPROVING AN APPROPRIATION OF THE
SB 358 STATE LIBRARY FUND #205

WHEREAS THE CITY COUNCIL of the City of El Paso de Robles hereby adopts an appropriation of the SB 358 State Library Fund #205 with the following understanding:

1. The expenditure budget is developed without function or line item detail but is presented for the purpose of purchasing more books.
2. This appropriation is for \$2,904.00 and is not to exceed the cash balance in this fund. If this appropriation is not used by the end of this fiscal year 1983/84, the balance will remain in fund #205.
3. The City Manager is authorized to transfer appropriations up to a limit of \$10,000.00 between functions and line items as it becomes necessary without further City Council action.


THEREFORE, the Council appropriates \$2,904.00 of the SB 358 Fund #205 for the fiscal year 1983/1984.

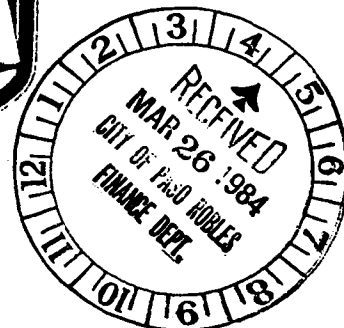

SUBJECT: 1983-84 ALLOCATIONS FROM THE PUBLIC LIBRARY FUND

You will find attached a list of California public libraries and the total 1983-84 allocation for each from the Public Library Fund. These allocations are made under Chapter 1.5 (commencing with Section 18010) of the California State Education Code.

Regarding the use of these funds by local jurisdictions, Section 18025(d) of the Code says: "...State funds provided under this chapter shall supplement, but not supplant, local revenues appropriated for such public library."

According to the law the Controller distributes the funds to the fiscal agent of eligible library jurisdictions. I have, therefore, identified in the attached list the fiscal agent who will be receiving your library's allocation.

The first payment will be for two thirds of the year's allocation; the remaining third will be distributed, according to law, on May 15.

It generally takes about six to eight weeks for payments of this kind to local jurisdictions to make their way through the Department of Education and the Controller.
