IN THE CITY OF EL PASO DE ROBLES (PASO ROBLES SCHOOL DISTRICT/NIBLICK ROAD)

WHEREAS, the City of El Paso de Robles, having on the 17th day of May, 1988, passed a Resolution of Intention to vacate a public right-of-way easement in the City of El Paso de Robles, County of San Luis Obispo, State of California, and more particularly described as follows:

> That portion of Parcel 3, shown as a public right-of-way easement sixty feet (60') wide recorded in Book 30, at Page 91, of Pancel Maps, also recorded as an irrevocable and perpetual offer to dedicate in Volume 2210 at Page 485 of Official Records, on file in the Office of the County Recorder of San Luis Obispo County, State of California.

Reserving however, to the City of El Paso de Robles the northerly two feet (2') for street purposes, the northerly eight feet (8') for a public utility easement, and the northerly seventeen feet (17') for a tree planting easement;

WHEREAS, it now appears that the City of El Paso de Robles did cause said Resolution of Intention to be published in the County News as required by law; and

WHEREAS, it further appears that said notices and public actions were in all respects completed as required by the provisions of an act of Legislature of the State of California entitled "Street Vacation Act of 1941" Division IX, Part 3, Chapters 1 and 2 of the Streets and Highways Codes; and

WHEREAS, a public hearing has been held on said proposed vacation as so noticed and having heard all evidence offered by any person interested, the City Council of the City of El Paso de Robles finds that the street as

described is unneccessary for present or prospective future public street purposes.

THEREFORE, BE IT RESOLVED, that the public right-of-way easement cease on said easement herein before described and be vacated for public street purposes.

BE IT FURTHER RESOLVED, that the City Clerk of the City of El Paso de Robles cause a certified copy of this Resolution to be recorded in the Office of the County Recorder of the County of San Luis Obispo, State of California.




