

GRANT OF AVIGATION EASEMENT

Lots 1 through 81, inclusive, Tract 1886, in the City of Paso Robles, County of San Luis Obispo, State of California.

1. The right of flight for the unobstructed passages of aircraft, for the use and benefit of the public, in the airspace above said imaginary surfaces, together with the right to cause in or about said airspace such noise, light, electromagnetic emissions, vibrations, fumes, dust, fuel particles, and all other effects as may be inherent in the navigation or flight of aircraft now or hereafter used or known, using said airspace for landing at, taking off from, or operating from, to, at, on, or over said Airport.

The easement granted herein and all rights appurtaining thereto are granted unto the City, its successors and assigns, until said Airport shall be abandoned and ceased to be used for airport purposes.

It is understood and agreed by Grantor(s) that this easement and the covenants and restrictions contained herein shall run with the land described above and shall be binding upon the heirs, successors and assigns of Grantor(s). For purposes of this instrument, the above-described real property shall be the servient tenement and the Airport shall be the dominant tenement.
