A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF

AGREEMENT EXTENSION WITH SONIC CABLE TELEVISION
FOR PROVIDING CABLE TELEVISION PROGRAMMING SERVICES

WHEREAS, the City Council and Sonic Cable Television is desirous of extending the term of the agreement until such time as renewal negotiations are completed.

THEREFORE, BE IT HEREBY RESOLVED by the City Council of the City of El Paso de Robles that the agreement attached herewith is hereby approved effective February 16, 1994 and the mayor is authorized to execute said agreement.

EXTENSION OF FRANCHISE AGREEMENT

This Agreement is made and entered into this 16th day of February, 1994, by and between the City of Paso Robles, a duly authorized municipal corporation (the "City") and Sonic Cable Leasing Corporation, an Alaska corporation ("Sonic").

RECITALS

WHEREAS, Sonic has operated a cable television system ("System") in the City pursuant to a franchise agreement ("Franchise Agreement") entered into between the City and Sonic Cable T.V., a California corporation, by Resolution No. 2266, passed and adopted on December 19, 1978, and transferred to Sonic following approval by the City Council on November 21, 1989 and the term extended by Resolution No. 93-189, passed and adopted on December 7, 1993; and

WHEREAS, the franchise under which Sonic has operated its System expires on February 28, 1994; and

WHEREAS, Sonic has requested that its franchise be renewed by the City; and

WHEREAS, the City Council has determined that the public interest would be served by attempting to negotiate a renewal of the franchise to Sonic; and

WHEREAS, Sonic and the City are in the process of negotiating and drafting a renewal franchise agreement; and

WHEREAS, the City Council has determined that the public interest would be served by granting to Sonic an extension of the franchise to and including June 30, 1994, pending finalization of the renewal franchise agreement.

NOW, THEREFORE, the City and Sonic do hereby agree as follows:

AGREEMENT

1. The City hereby grants to Sonic an extension of the franchise to and including June 30, 1994, pending finalization of the renewal franchise agreement.

2. Except as otherwise provided herein, all terms and conditions set forth in the Franchise Agreement shall remain in full force and effect.

3. It is mutually agreed by the City and Sonic that when a renewal franchise agreement is reached and entered into by the City Council of Paso Robles and Sonic, the term of this Extension shall immediately expire.
